Judges or other regular members of the judiciary are not eligible for nomination to membership, but a member appointed or elected to the bench of any court may continue to serve as a Fellow with the Academy.

Membership dues are \$400.00 per calendar year and should accompany your application. Dues will be refunded or returned if the board does not accept the application.
